RE: House Resolution No. 1450, recommending its adoption with amendments

SPONSORS: Reps. Villafuerte et al., and the Members of the Committee on Rules

Mr. Speaker,

The Committee on Rules has considered House Resolution No. 1450, authored by Reps. Villafuerte, et al., entitled:

“RESOLUTION CALLING FOR THE CONVENING OF CONGRESS TO PROPOSE AMENDMENTS TO, OR REVISION OF, THE CONSTITUTION UPON A VOTE OF THREE-FOURTHS OF ALL ITS MEMBERS, PURSUANT TO SECTION 1, ARTICLE 17 OF THE CONSTITUTION”

and recommends its adoption by the House of Representatives with the following amendments:

1. On page 1, 5th paragraph, delete the phrase “the convening” and in lieu thereof put the phrase ALL THE MEMBERS;
2. On the same page, last paragraph, delete the phrase “THAT CONGRESS BE CONVENED PURSUANT TO SECTION 1 SUBPARAGRAPH 1 OF ARTICLE XVII OF THE CONSTITUTION” and in lieu thereof put the phrase “TO CALL ALL MEMBERS OF CONGRESS, PURSUANT TO SECTION 1 SUBPARAGRAPH 1 OF ARTICLE XVII OF THE CONSTITUTION, TO PROPOSE AMENDMENTS TO, OR REVISION OF, THE CONSTITUTION AT THE PLENARY HALL OF THE HOUSE OF REPRESENTATIVES, BATASAN COMPLEX, QUEZON CITY BEGINNING AT TEN O’CLOCK IN THE MORNING OF DECEMBER 11, 2006 UNTIL THE APPROVAL OF THE PARTICULAR AMENDMENTS OR REVISION OF THE CONSTITUTION FOR SUBMISSION TO THE PEOPLE FOR THE PURPOSE OF RATIFICATION IN ACCORDANCE WITH SECTION 4, ARTICLE XVII OF THE CONSTITUTION ”
3. To replace the title to read as follows:

“RESOLUTION CALLING ALL MEMBERS OF CONGRESS TO PROPOSE AMENDMENTS TO, OR REVISION OF, THE CONSTITUTION, PURSUANT TO SECTION 1, ARTICLE 17 OF THE CONSTITUTION AND FOR OTHER PURPOSES”
